Presidents Message

Dear Friends and Neighbors,

I hope this message finds you enjoying your summer with your family, friends and neighbors. It is such a magical time on the Point; beautiful weather, warm water and smiling faces all-around!



The Community Foundation of Balboa Peninsula Point (CFBPP) is a philanthropic organization founded in 2006 to improve the quality of life of our neighborhood. Our revenue is derived from donations and those funds have been put to use in multiple ways. Some examples of investments over the years have been; installation of the Tot Lot at the corner of Miramar and Balboa Blvd, funding of the landscape for the new island at I and Balboa Blvd., commissioning both murals in and around the Village (Chronic Taco building and Pump Station at A Street), and for the last 12 years, funding the security patrol. Security and Safety have been the most often re-quested use of funding, so a number of years ago we focused our fundraising goals on achieving \$100,000 a year in donations so we could support a year round patrol (originally was a summer only program). Thanks to the generosity of many of our neighbors, we achieved that milestone in 2024 and have committed to a year round program this year! But one year does not make a trend, so our goal now is to sustain this level of fundraising to allow us to have a reliable and consistent Security Patrol. The key to our success is to broaden our donor participation. We have approximately 800 households on the Point. We currently see about 35% of our house-holds donating, so clearly room to move in establishing reccurring annual funding to not only continue the year round evening/night patrol, but also to expand, as appropriate, the coverage in hours.

This newsletter will also provide information about our investment in a License Plate Reader, which is installed on the Balboa Realty building on the corner of A street and Balboa Blvd. As you will see in the subsequent article, we worked with the City and Police Department on the initiative and the system is being used by Law Enforcement to assist in event investigation. Finally, our Treasurer, Russ Doll, has provided a financial report to show how our funds are spent and, most importantly, how you can donate!

We appreciate the support from those who have donated. For those that have not, we would kindly ask you to consider making a donation this year. The efforts the Foundation focuses on benefits all neighbors so it only seems fair to ask everyone to make a contribution towards these neighborhood investments.

History of the License Plate Reader Installation

License Plate Reader (LPR) installations are becoming more common as a crime deterrent and a law enforcement tool for crime solving. LPRs consist of narrow field-of-view cameras pointed at strategic neighborhood entrance/exit locations, video storage equipment with date/time data and internet access to allow authorized law enforcement authorities to access data as needed.

Incidents in past years led the Foundation to investigate installation of an LPR system for Peninsula Point. NBPD is very supportive of such systems and referred us to operating systems on Lido Island and Balboa Island. Subsequent interactions with Lido Island HOA and Balboa Island Merchants Association convinced us that an LPR system would be beneficial for us and we proceeded to implement it.



The optimum location for a Peninsula Point installation is at A Street and E. Balboa Blvd. At that time, the City of NB would not allow us to install on the A Street Island and we had to find another site in Balboa Village. Several sites were considered, but we were fortunate to get approval to do the installation on the best location, Balboa Realty office on E. Balboa Blvd. They gave us access to the location and secure space inside to house the data recorder and internet


access equipment and we have been operational since 2022. (see photo). The foundation pays a modest rental fee to Balboa Realty to allow access as needed for equipment maintenance and/or repair. For data privacy reasons, the Foundation does not have access to the LPR stored data. Instead, we employ an independent third party to provide data requested by NBPD and other authorized government agencies.

Although specific law enforcement actions are not public, we have answered requests for data and have been assured that the system is operating as planned and providing useful data.

Thanks to Balboa Realty for giving us access, NBPD and other law enforcement authorities for keeping us safe and to CFBPP donors for your continuous support of this valuable community asset.



The residents have two outstanding organizations supporting the community. The **Balboa Peninsula Point Association** and the **Community Foundation of Balboa Peninsula Point**. The organizations are complementary and work in tandem to bring support to our community. On occasion we receive questions about the roles and focus of each. - Publishes an Annual Membership Directory
- Monitors City Council, Airport, Police and Public Works for issues that affect the Peninsula Point
- Supports Community Emergency Response Team (CERT)
- Publishes the periodical POINTER

As summarized above, for the year ended December 31, 2023, CFBPP had total Program Expenses of \$95,540, including seven days a week security patrols for the entire year. In addition, CFBPP continued to fund the annual hosting and monitoring costs of the License Plate Reader (LPR) technology that was installed over two years ago. The daily security patrols and the LPR technology comprise the CFBPP's Security Programs and represent 90% of 2023 Program Expenses.

While Security Programs are the primary focus of the current mission, CFBPP continues to support community related beautification efforts including local public art, landscape, and family-oriented enhancements to our Peninsula Point Community. Since CFBPP's founding over 15 years ago, its volunteer Board of Directors has committed to putting your generous support directly back into our community based on the highest priorities identified by our donors to benefit all residents. Consistent with previous years, CFBPP spent 94% of its annual Program Expenses on these priorities. The remaining expenditures represent fund-raising and administrative costs necessary to communicate with our residents and cover the annual administrative expenses to comply with Federal and State non-profit requirements.

In 2023, we reached out to neighbors with an appeal to raise \$100,000 annually to fund an expanded yearround Security Patrol. The positive response to this appeal and generous support of our friends and residents allowed us to achieve this goal in 2023. As a result, we entered 2024 with a commitment to continuing the Security Patrol on a full-time basis. To sustain this program into the future, we need to maintain, and grow, the \$100,000 annual level of support. As always, we thank our Peninsula Point neighbors for supporting CFBPP. We appreciate your feedback and ideas on how the mission of CFBPP can evolve to continue to support and enhance the quality of life for all of us.
